

ARTICLES OF INCORPORATION
OF
THE SALT LAKE MONTHLY MEETING OF THE RELIGIOUS SOCIETY OF FRIENDS

I, the undersigned, a natural person being of the age of eighteen years or more, in unity with the members and attenders of the Salt Lake Monthly Meeting of the Religious Society of Friends, a religious organization in the tradition of Quakers, adopt the following Articles of Incorporation for the purpose of incorporating said Meeting.

ARTICLE I
CORPORATE NAME

The name of the corporation is The Salt Lake Monthly Meeting of the Religious Society of Friends.

ARTICLE II
DURATION

The period of duration of this corporation is perpetual.

ARTICLE III
PURPOSES

This corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

More particularly, this corporation is organized for the religious purpose of supporting and maintaining the meeting of Quaker Friends and those in the area of northern Utah interested in the faith and practices of Quakers, including charitable and educational support of members and others associated with the meeting, charitable and educational support of groups and persons in the wider community or elsewhere, the support of other Quaker organizations and all organizations pursuing practices and goals consistent with the Quaker faith, and for such purposes as are useful and necessary for this general purpose, including, but not limited to:

- (a) Purchasing, owning, maintaining, encumbering, selling and conveying real and personal property;
- (b) Soliciting and receiving contributions, monetary or in kind; entering and performing contracts; depositing, saving and investing corporate funds; spending corporate funds for corporate purposes; and engaging in any activity "in furtherance of, incidental to, or connected

with any of the other purposes";

(c) Engaging in any and all other lawful purposes, activities and pursuits that are substantially similar to the foregoing and that are or may hereafter be authorized by section 501(c)(3) of the Internal Revenue Code and are consistent with those powers described in the Utah Nonprofit Corporations and Cooperation Association Act, as amended and supplemented.

ARTICLE IV LIMITATIONS

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to, its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Code, or the corresponding section of any future federal tax code.

ARTICLE V MEMBERS AND SHARES

The corporation shall have a single class of voting members, consisting of the enrolled members and regular attenders of the Salt Lake Monthly Meeting of the Religious Society of Friends, as set forth more particularly in the bylaws of the corporation. This corporation will not issue shares.

ARTICLE VI LIMITATIONS UPON LIABILITY OF DIRECTORS

The directors and officers of the corporation shall not be individually or personally liable for the debts or obligations of the corporation to the fullest extent permitted by law.

ARTICLE VII
ANNUAL REPORT

The corporation shall report at least annually on its financial and general operations to the members of the Salt Lake Monthly Meeting of the Religious Society of Friends.

ARTICLE VIII
DIRECTORS

The number of directors constituting the Board of Directors shall not be less than three (3), with the exact number of directors to be set from time to time by resolution of the Board of Directors. The rights, privileges and duties of the directors and the manner of their election and removal shall be as set forth in the bylaws. The names and addresses of the persons who are to serve as directors until their successors are chosen by the members are:

ARTICLE X
DISTRIBUTION OF ASSETS UPON DISSOLUTION

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, as amended or supplemented, or shall be distributed to the federal government or to a state or local government for a public purpose. Any such assets not so disposed of shall be disposed of by the District Court of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
